THE RESIDENTIAL TREATMENT PROGRAM PROVIDES AROUND-THE-CLOCK CARE FOR YOUTH WHO REQUIRE THERAPEUTIC SERVICES TO DEAL WITH MODERATE, SEVERE, OR INTENSIVE EMOTIONAL DISTURBANCES, BEHAVIOR DISORDERS, AND/OR MENTAL HEALTH DIAGNOSES. THE PROGRAM IS DESIGNED TO PROVIDE INTENSIVE TREATMENT WHICH WILL ENABLE YOUTH TO TRANSITION TO LESS RESTRICTIVE HOME-LIKE SETTINGS. THE SERVICES ARE PROVIDED IN A NURTURING ENVIRONMENT DESIGNED TO HELP KIDS IMPROVE THEIR SELF ESTEEM, LEARN, AND MOVE TOWARD REACHING THEIR FULL POTENTIAL AS PRODUCTIVE MEMBERS OF THE COMMUNITY. THE FACILITY IS LICENSED BY THE STATE OF MISSOURI FOR A CAPACITY OF 41 KIDS BETWEEN 12 - 18. THE RESIDENTIAL TREATMENT PROGRAM SERVED 55 CHILDREN IN 2009.

THE PRIVATE ALTERNATIVE SPECIAL EDUCATION SCHOOL PROVIDES SPECIAL EDUCATION SERVICES FOR CHILDREN WITH SEVERE EMOTIONAL DISTURBANCES. CHILDREN RECEIVE INDIVIDUALIZED ACADEMIC AND THERAPEUTIC SERVICES AS SPECIFIED IN THEIR INDIVIDUAL EDUCATION PLAN. THE PROGRAM OFFERS AN ALTERNATIVE TO THE TRADITIONAL CLASSROOM SETTING WHICH IS DESIGNED TO HELP EACH STUDENT PROGRESS ACADEMICALLY AS WELL AS SOCIALLY AND EMOTIONALLY IN ORDER TO SUCCESSFULLY REINTEGRATE INTO A TRADITIONAL CLASSROOM SETTING. THE SCHOOL SERVED 95 STUDENTS IN 2009.

THE EMERGENCY SHELTER PROGRAM IS DESIGNED TO HELP CHILDREN AND YOUTH AGES 6-18, WHO ARE RESIDENTS OF THE CITY OF ST. LOUIS AND AT RISK OF FAMILY PLACEMENT DISRUPTION OR OUT-OF-HOME PLACEMENT. THE CHILDREN AND FAMILIES PARTICIPATING RECEIVE UP TO 30 DAYS SHELTER PLACEMENT, INDIVIDUAL AND GROUP THERAPY, TRANSPORTATION TO SCHOOL AND OTHER EDUCATION SUPPORT. THE PROGRAM SERVED APPROXIMATELY 30 YOUTH IN 2009 BEFORE THE PROGRAM ENDED IN JUNE DUE TO LACK OF FUNDING.
